- 2) Complete the online application with *Smart Tuition*. (application fee of \$35) The *Smart Tuition* application can be accessed by going to **smartaidforparents.com** and following the instructions there using our school code: 05717
  - a) Check with the school office BEFORE you apply for financial aid. LCS has limited funds to allocate for financial assistance.
  - b) *Smart Tuition* will ask for required supporting documentation before they make a recommendation. Be sure to submit all documents required.
  - c) The tuition assistance application deadline is May 18th, 2021. No assistance will be granted after that date.
- 3) A representative from the LCS Business Office will contact you after the school has received a recommendation from *Smart Tuition*.

### **Early Registration Discount Rates**

Please see the Schedule of Rates form for discounted rates. These rates apply until March 1, 2021. Registration fee must be paid at the same time as application turn-in.

#### **Referral Discount**


